Mass arbitrary detention of Uyghurs, Kazakhs, and individuals belonging to other, mostly Muslim nationalities in political reeducation camps in China's northwestern Xinjiang region, also known as East Turkestan, is among the most controversial phenomena seen by the world in the 21st century. Yet this unprecedented measure is merely one of multiple aspects of China's extreme reengineering of local Muslim societies. These also include family separations, forced labor, ubiquitous technological surveillance, and uprooting of religious, linguistic, and cultural practices. As the atrocities committed by Chinese authorities in East Turkestan invite comparisons with mass incarcerations and crimes against humanity committed elsewhere in the world, the crisis has also become an irritant of China's relations with a part of the international community. This debate brings together activists and experts who will discuss latest developments in East Turkestan and their international implications.
